Message from the Executive Co-Directors



As Executive Co-Directors, we warmly thank each and every supporter of Foothills Academy. Despite the turbulent economic challenges in Alberta, we have continued to see tremendous support for the life-changing work we do here at Foothills, in the School and in Community Services. It is a testament to the recognition of the importance of our work that we maintain such incredible supporters for our programs. Thank you all for making a difference in the lives of so many children, youth and young adults living with Learning Disabilities.

This year has seen a number of new initiatives. In October 2017, we hosted the Centre of ADHD Awareness Canada (CADDAC) annual conference with Dr.

Thomas E. Brown as the keynote speaker. The two-day event was a unique educational opportunity and was very well attended by parents, teachers, and other professionals in the Calgary area.

Our "Inside Learning Disabilities" ten-week online course was launched in January 2018. The Educator version of the course has already received outstanding feedback and has already been utilized by hundreds of teachers, including entire school staff groups, in Calgary and across Canada. The Parent version of the course will be offered free-of-charge until the end of 2018 in order to increase the accessibility of the information to families. All of this has been supported by an Anonymous Donor through the Calgary Foundation which also supported the website redesign process we are currently undertaking.

As ambassadors for the individuals with unique learning needs, we continue to support and advocate for this population at the local, provincial, and national levels. We each sit on several Boards and committees, including: Learning Disabilities Association of Alberta (LDAA); Learning Disabilities Association of Canada (LDAC); Association of Independent Schools and Colleges in Alberta (AISCA); the Centre for ADHD Awareness Canada (CADDAC); and the Calgary Regional Service Delivery Collaboration (Calgary RCSD). We are particularly proud that Foothills Academy is a backbone agency leading the Calgary Region LD & ADHD Network; a collective impact group working to help local families find appropriate supports.

We have achieved so much since our inception in 1979 and we continue to provide much needed services and supports as envisioned by our founders, Tom Aylesworth, Gordon Bullivant, and Bill and Beth Mackesy. Without the ongoing generosity and support of the community, we would not have been able to come this far and meet the life-changing needs of so many children, youth, adults and families living and working with Learning Disabilities. So we want to thank every stakeholder, investor, supporter and champion of Foothills Academy, for being an integral part of our success.

Our Mission




2017 - 18 Financial Summary

Overall, there have been no major changes in revenue and expenses over the previous year. With the government keeping per student funding at the same rate as last year, it has essentially meant a cut in revenue for our school program as expenses such as salaries and other costs like bussing continue to climb.

One of the other demands on our budget is our commitment to having substantial Mental Health, Occupational Therapy and Speech Language Therapy services available for our students. The funding that is provided through the Regional Collaborative Service Delivery (RCSD) (\$9,000 per year) does not come close to covering the true need of students at Foothills. As an organization, we have chosen to cover the costs of providing this service out of our own budget which is approximately \$150,000 per year in direct costs. If indirect costs were included, the true cost to us to provide these services to our school students is over \$250,000 per year.

Keeping an eye on preparing for the future, the board directed that \$393,000 be allocated to a building Maintenance Reserve fund as per a building life cycle review conducted by an engineering firm and that \$472,583 be allocated to an Operating & Bursary Program reserve. Capital spending included the replacement of a portion of the roof and HVAC equipment as well as replacing and upgrading technology - especially Smartboards.

Recognizing that our School Program and Community Services families are also experiencing financial strain, the board decided to keep fees for programs at the same level as last year. Trying to ensure financial accessibility while being prudent fiscal managers has been a strong focus for us as an organization. But, we are reaching a point where are surpluses which are allocated to capital and operating reserves are becoming smaller and smaller. To increase our revenue, we have had to look at alternative sources of income such as renting out our facility after school hours.

We are always grateful for the tremendous community support plus the efforts of parents, staff, board and volunteers to raise much needed funds and we were also fortunate to receive several one-time major donations this past year. Most of our fundraising efforts go toward supporting our Bursary Fund and in 2017/18, these fundraising efforts allowed us to approve all 238 bursaries that were applied for that were valued in excess of \$966,975.



Fulfilling our Mission in 2017 - 18

School Program



Our school program was full in 2017/18 with 289 students. Most grades have waiting lists which is a tribute to the success of our program.

Students are living in a more complex and complicated world, and it is hugely important for us to continue to support every area of these students' complex lives. We continue to support the social and emotional needs of students, in high-need areas such as anxiety (especially test anxiety), as we implement more supports upon specific professional development for staff, mindfulness in the classroom, regulation strategies and programs, and therapy dogs at high-stress times during exams and tests.

Math performance has been a focus at the provincial achievement level and internally at Foothills Academy. This past year we started using a Math Coach in the younger grades and focus upon visual learning in Math. Thanks to this, our grade 6 students bucked the Provincial trend and showed growth in Math Provincial Achievement Tests. Given this success, we will implement similar coaching in higher grades moving forwards.

It is always a pleasure to recognize our graduating class each year. In June, we were thrilled to witness a large class of 36 students cross the stage. We have students who may not necessarily have graduated elsewhere, graduating and heading off to post-secondary and the workplace. National statistics would suggest that graduation rates for students with Learning Disabilities are less than favourable and our consistently high graduation rate from Foothills is something that we celebrate; especially considering the academic, social and emotional gains that many students make. We are hopeful that we have prepared them well for their post-graduation life through progrmas like our Adventures Pursuing Post Secondary program,. This is a partnership initiative with SAIT to expose students to the demands of post-secondary education and provide them with skills and experiences to help with the transition after high-school. We have also invested heavily in Futures Planning starting in grade 9. For our most recent graduates, 70% had applied for and were accepted at a post-secondary institution for this coming year.

A complete school performance report and three year plan is submitted annually to Alberta Education and is available on our website.





Donations in Action:

Bursary assistance was applied for and approved for 95 families (33% of families) for a total of \$855,000.

"Can you imagine what it is like to have your 8 year old child run away from home and say that he didn't want to live because of how he was being treated at school?

That is the situation we faced when our child was in grade 3 because he had a teacher who did not believe in our child's Learning Disability. Not unlike other parents, we wanted our child to learn to read, write and do math; to enjoy attending school; and, to not feel like he didn't belong. We didn't think that was too much to ask but apparently it was until we found Foothills. Our initial connection was through Community Services where our son started in the Read/Write program. Through the five-week program, his reading level went from grade 1 to grade 4 and his confidence in himself soared. We enrolled him in the school program and he loved going to school! We are eternally grateful for bringing out the best in our son and helping him to reach/understand his potential."

directly participated in one of our programs or services. Operating at or near capacity, these include our Read/Write & Math one to one instruction; psycho-educational assessments, counselling or group programs; social skills-based Camp Amicus and Amicus Recreation programs.

More important than the numbers are the success stories that come out of individuals. Children who were non-readers

can now read with confidence. Children without a friend who rarely left the house now eagerly come to Amicus programs where they connect with friends and learn skills they can use in their school and homes.

Parent Education and Professional Development

Part of our mission is to share our knowledge of Learning Disabilities beyond our direct programs. We accomplish this through our Parent Education and Professional Development department. We also do this through monthly articles written by our staff which are posted on our website and communicated through our e-newsletter to subscribers.

Donations in Action:

Bursary demand remained steady this year. In total, \$112,000 in bursaries was provided to 143 people in order for them to access the programs and services that would help them and their family.





Fundraising and Donations



Thanks to the generous donors, sponsors, parents and staff, \$998,164 (after fundraising expenses) was raised for Foothills Academy Society in 2017/18. This figure includes just under \$68,000 which was donated specifically for our Amicus programs. Compared to 2016/17, we increased fundraising by 12% which is impressive given the economy and given that there were two separate golf tournaments that were counted in 2016/17. This year we were fortunate to have additional funds raised through the Birdies for Kids program which we hope we will benefit from on an ongoing basis. We also benefitted from the one-time Mountains & Marathons event and the FAPA Casino which occurrs approximately every 18 months. We are pleased to see that donations are about \$30,000 higher than last year. Our endowment funds continue to perform well and provide much needed, reliable long-term funding. Recognizing that the demand for financial assistance continues to grow, we continue to

Donor Spotlight: Anonymous Donor at the Calgary Foundation



An Anonymous Donor at the Calgary Foundation donated money to Foothills Academy Society to help redevelop our website which will launch in late 2018. With the redesigned website, it will be easier for visitors to quickly understand the dual nature of Foothills Academy Society - a school and Community Services. It will be easier for visitors to navigate and quickly find the programs or resources they are searching for. And, for our school families, the website allows access to much more comprehensive

information and resources to improve overall communication between Foothills Academy and home.

The donation also allowed for our Parent Education and Professional Development department to use state of the art software to design and manage online education aimed at both parents and educators. Because they're online, the courses can be accessed by people locally, provincially, nationally and beyond. The platform will also allow us to post webinars and other online learning tools. This donation allows us to economically reach significantly more people and provide resources to those who may live in rural or remote locations without specialized resources locally. The first course offered was Inside Learning Disabilities for Educators. In 2018/19, we will offer Inside LD for Families and introduce Inside ADHD for Educators.

The development of both our website resources and online learning courses helps us to fulfill our mission of being part of the wider community to help increase knowledge of Learning Disabilities in Calgary and beyond.



A Monumental Achievement

At our Fall Funtasia gala in November 2017, Simon Williams announced the launch of a fundraising campaign called Mountains and Marathons to coincide with the annual Charity Challenge event at the Scotiabank Calgary Marathon. Simon, in partnership with Centron Construction Group's CEO Wayne Benz sought to overcome the challenge of mountains and marathons to reflect the challenges that students with Learning Disabilities have daily. Together, they committed to bike and run 289 miles - one mile for every student who attends Foothills Academy - in one day to raise awareneess of Learning Disabilities and raise money for the Bursary Fund at the same time.
