All ticket sales will be processed through Stride's Certified ERS, with transactions processed through SMCCheckout. Purchases will be via credit card or debit; no cash or cheques will be accepted for ticket purchases.

- 4. Purchase price of tickets will be \$20 each or five (5) for \$50 or ten (10) for \$75 or twenty-five (25) for \$100.
- 5. The total number of tickets available for sale will be 52,375.
- 6. Tickets will be available for purchase until 11:59 pm, November 16, 2022. Draw will take place on November 18, 2022 at Stride Management Corporation 3950 12 St NE, Calgary, AB T2E 8H9.
- 7. Draw will take place in person at approximately 4:00pm using Stride's RNG to conduct the draw.

Cash or Truck Raffle
